Notices issued in Nepal Gazette

Ban on import of goods

The Government of Nepal vide its notice on 13 Baisakh 2079 (26 April 2022) has imposed a ban on the import of items such as:

- cigarette and other tobacco related products except for raw materials;
- motorcycles over 250 cc;
- automobiles other than ambulances and hearses;
- playing cards;
- alcoholic beverages except for raw materials;
- all kinds of toys;
- mobile phone sets costing over USD 600;
- television sets bigger than 32 inches;
- chips;
- and diamonds.

The ban shall be in place till the end of the current fiscal year 2078-79.

Notices issued by Nepal Rastra Bank

Amendment in directive related to integrated payment system

Directive 5/078 1(5): The amount transferred from credit cards to digital wallets shall only be used for the purchase of goods and services electronically. A system for restricting the transfer of the amount to the bank

and withdrawal in cash shall be implemented by the concerned service providing organization.

Directive 14/078 1 (6) & (7):

(6) Declaration shall be taken from the customer that all information provided by the customer is true and if found false will be liable for punishment by law while opening a digital wallet account and updating the customer identification form.

(7) Purpose shall be compulsorily disclosed while transferring the amount from one digital wallet to another or while making an electronic transaction from a digital wallet.
