Notices issued by IRD

Notice regarding self-verification of E-TDS

IRD has launched an online system of self-verification of e-TDS returns by taxpayers. Previously VAT return, ITR, estimated returns and e-billing could be only be verified online. For notice and procedures of online verification of e-TDS <u>click here</u>.

Notice to pay outstanding VAT amount

IRD has made public the list of defaulting taxpayers with a notice to deposit the long overdue VAT within 15 days of publication of the notice i.e. 17/02/2021 failure of which penalty under section 21 of VAT Act 2052 shall be attracted. For notice click here

Amendment in Income Tax Directives, 2066 (with 3rd amendment, 2077)

IRD has updated the Income Tax Directives 2066 to rectify some general errors therein and issued the updated version.

Similarly, the IRD has announced that all BFIs providing exchange facility for the fees of language test and other standard tests of students going abroad should withhold 15% tax on the fees to be repatriated. It has also notified that withholding tax of 2.5% should be made at the custom point on import of various items. For details <u>click here</u>
