



COVID-19 update in Nepal

Government of Nepal has removed almost all prohibitory orders and decided to open almost all business within Kathmandu Valley however local governments have imposed lockdown in different parts of Nepal considering local status of COVID-19. There has been a significant spike in COVID-19 cases in Nepal of late with the infection spreading across the country with 191,636 confirmed cases, 1,087 deaths and 155,114 recovered as of 8 November 2020.

Four staff of PKF TRU tested positive for the Corona despite of all precautionary measures and three of them have recovered without facing any significant complications.

Dashain Celebration



Dashain is the biggest Hindu festival celebrated by not only Hindus but all Nepalese as "the triumph of good over evil". ICAN through its notice dated 2077.07.14 has instructed to implement notice published on 2077/3/30 and on 2075/5/31 where date has been extended on carve out for NFRS. ICAN has further clarified that no further carve outs have been provided and directed members to certify financial as per instructions failure of which will attract penalty as per rule 64 of ICAN Rules 2061.
